

CORPORATE STATEMENT

OFFICIAL LEGAL & OPERATIONAL CLARIFICATION DOCUMENT

This Statement is made and executed to formally clarify, document, and bind the financial transactions, operational documentation, and corporate responsibilities involving the three interconnected entities detailed below.

1. DEFINITION OF ENTITIES

For the purposes of this Statement, official documentation, and all past, present, or future financial transactions, the following definitions shall apply:

Amdani Global: The online e-commerce storefront, digital marketplace, and direct operational extension of Raz Corporation.

Resimex Corporation: An unregistered trade name that holds no independent legal status, conducts no independent commercial operations, and does not enter into agreements in its own capacity. The digital platform and website used by Amdani Global were developed under this trade name for and on behalf of Amdani Global. Technical development and maintenance services are associated with this name; however, no liability is assumed under this trade name for the commercial operations, transactions, content, or business practices conducted on or through Amdani Global.

Raz Corporation: The legally recognized parent entity operating, managing, and assuming responsibility for the digital assets and operational activities conducted under the names Resimex Corporation and Amdani Global in all operational, logistical, and financial capacities.

2. LEGAL STATUS & RESPONSIBILITY

Unified Responsibility

All business activities including, but not limited to, digital sales, vendor agreements, and customer fulfillments processed via the online storefront, Amdani Global—are fully backed, recognized, and legally bound by the parent entity, Raz Corporation.

Compliance & Validity

The executing parties acknowledge that all contracts, invoices, and digital agreements executed under the trade name Amdani Global carry the full legal weight of a standard corporate commitment enforceable against Raz Corporation.

3. FINANCIAL TRANSACTIONS & DOCUMENTATION

Accountability

All financial transactions including incoming revenue, outgoing payments, lines of credit, invoices, and banking documentation generated by or for Amdani Global—shall be accurately recorded, reconciled, and integrated into the financial accounting systems of Raz Corporation, acting in its capacity as the primary responsible legal entity.

Documentation Integrity

Any documentation, including bills of lading, purchase orders, digital receipts, and tax invoices bearing the name Amdani Global, shall be treated as valid, legally binding evidence of commercial transactions. Raz Corporation undertakes to honor, verify, and maintain these records in strict compliance with applicable corporate and financial regulations.

Raz Corporation, in its capacity as the parent entity governing Amdani Global, guarantees the fulfillment of all financial obligations and transactional undertakings documented under these names.
